# 《申请学生签证担保及声明书》

#### Application for Student Visa Sponsorship and Declaration

致非本地学生申请签证 / 进入许可之说明 Notes to Students

- 1. 按照香港的法律规定,凡没有香港特区居留权或入境权而拟来港求学的人士,都必须在来港前取得由香港特区政府入境事务处签发有效的学生签证/进入许可。凡持有有效的香港特区学生签证/进入许可者、非本地毕业生留港/回港就业安排(IANG)的签証/进入许可或受养人签証/进入许可証(在获香港特区入境事务处签发受养人签証/进入许可时已年满18岁),均定义为"非本地学生"。
  - Persons who do not have the right of abode or right to land and wish to enter Hong Kong for the purpose of education are required by law to obtain a valid student visa/entry permit issued by the Hong Kong Immigration Department before coming to Hong Kong. Students who hold a valid student visa/entry permit, visa/entry permit under the Immigration Arrangements for Non-local Graduates (IANG) or dependent visa/entry permit who were 18 years old or above when they were issued with such visa/entry permit by the Hong Kong Immigration Department will be classified as "Non-local Students".

  Travelers who entered Hong Kong as "Visitors" are not allowed by law to enroll as a student. Do not seek to enter Hong Kong in a "Visitor" status if you plan to study in Hong Kong.

  - It is the student's responsibility to understand and comply with the immigration and visa regulations. Vocational Training Council (VTC) will assist non-local students with their student visa/entry permit applications and act as their local sponsor if immigration requirements for studying in Hong Kong are met. However, it is the student and not VTC or any other person of VTC who is ultimately responsible for abiding by the visa regulations and maintaining a legal student status.

The amount of funds you need depends on the amount of tuition fee of the programmes or disciplines you are admitted to, the cost of accommodation and living expenses.
