## Addendum

The Immigration Department (ImmD) will adjust the application procedures for **entry** of visas/ entry permits for dependants, foreign domestic helpers, imported workers, students, training and working holiday with effect from **19 June 2023**. Applicants will be required to declare whether they have any criminal convictions when they apply for relevant entry visas/ entry permits. Application procedures for extension of stay, and for foreign domestic helpers currently working in Hong Kong applying for contract renewal with the same employer or for completing the remaining/ extended period of the current contract with the same employer and for change of employer in Hong Kong, will not be included in this adjustment.

2. As a transitional arrangement, the ImmD will continue to process applications for the above types of visas/ entry permits that reach the ImmD **on or before 18 June 2023**, regardless of whether declaration on criminal convictions has been made.
